

## CIE 2025 Overview of Author Agreements as Required for Final Submissions

This document contains an overview of the statements and agreements that submitting authors will have to confirm as part of completing the final version submission process (note that the legally valid documents and statements are those that will be referenced in the submission system). Authors should please make sure they have all necessary confirmations from co-authors, employers, or any other relevant entity at the time of submission.

- (I) Authors will have to confirm that they used the CIE final versions submission templates and have read and regarded the *Updated CIE 2025 Author Guidelines*.
- (II) Authors will have to confirm the *Submitting Author Statement*.
- (III) Authors will have to confirm the *Research Integrity Statement*.
- (IV) Authors will have to confirm the *Data Use Statement*.
- (V) Authors will have to confirm the *CIE 2025 Publishing Agreement*.

### Ad (II) Submitting Author Statement

As the submitting person, I understand and confirm that I am responsible for having obtained the agreement of any fellow co-authors to submit this contribution and to consent to the necessary agreements (in particular the publishing agreement) as required and chosen during the submission process. I confirm that all authors have agreed the priority of the assertion of copyright and the order of names in the publication of the article.

The legal responsibility for issues such as ensuring to abide to CIE research integrity standards remains jointly with the submitting authors.

### Ad (III) Research Integrity Statement

The author(s) guarantee(s) that the work is original, has not been published previously, or is not under consideration for publication elsewhere.

The author(s) guarantee(s) that the work has cited relevant references appropriately; this includes sections of text verbatim copied from other publications by the same author or other authors. The author(s) guarantees that any necessary permission to re-use material from another source has been obtained.

The author(s) guarantee(s) to respect the CIE Code of Ethics and to have abided to the CIE Research Integrity Standards, as defined in the author guidelines (for example: CIE Code of Ethics, Singapore Statement on Research Integrity, ÖAWI Guidelines for Good Scientific Practice).

Deviations from these standards will result in withdrawal from the conference program and/or publications and may have further legal consequences.

### Ad (IV) Data Use Statement

I/we confirm that the CIE Scientific-Services GmbH and the CIE (International Commission on Illumination) are allowed to process, store, and publish submitted information as required and purposeful in the organization of the conference and for the publication and dissemination of the Proceedings of the CIE.

CIE Scientific-Services GmbH (ZVR 640982399) and CIE (International Commission in Illumination) (FN 329027p) are registered in Austria and act in conformity with the General Data Protection Regulation

(GDPR, 2016).

## Ad (V) CIE 2025 Publishing Agreement

Authors of accepted contributions for the scientific conference CIE 2025 (7-9 July, 2025), to be held as part of the CIE Midterm Meeting in Vienna in 2025 explicitly agree to the following terms and conditions of the CIE 2025 publication agreement.

Completing the submission process (as part of which, a confirmation of this publishing agreement is compulsory) constitutes a binding contract – publishing agreement – between the author(s), as indicated in the submitted final versions and the Publishers (International Commission on Illumination and CIE Scientific-Services GmbH which is fully owned by International Commission on Illumination).

The confirmations and statements (*Conformity with Author Guidelines, Research Integrity Statement, Submitting Author Statement, Open-Access Purchase, Data Use Statement, other*), as requested from the author(s) during the final version submission process, form an integral part of the complete terms and references related to this publishing agreement.

The submitting author(s) assign the CIE (International Commission on Illumination) the right to publish the relevant work as submitted to the CIE through the conference submissions system in conference publications (abstract booklets, etc.), and in particular in the publication series (ISSN no. 3061-015X (print), 3061-0168 (online)) entitled *Proceedings of the CIE (International Commission in Illumination)*, owned and published by the CIE, and managed and distributed by the CIE Scientific-Services GmbH.

The CIE is assigned the exclusive right to publish, republish, transmit, sell, license, distribute and otherwise use the submitted work (Full-length Paper or Short Paper) and the material contained therein wholly or in part in electronic and print editions of the CIE publications and in derivative work throughout the world, in all translations and languages and in all media of expression now known or later developed, and to license or permit others to do so. The assigned rights are not time-bound and apply to any copyright renewals and extensions and all subsidiary rights, subject only to the following: The author retains the right to (1) deposit the final peer-reviewed manuscript (submitted final version) in an institutional repository or open archive without charge (an embargo period of 12 months applies) or (2) in any collection consisting solely of the author's own works without charge, and subject only to notifying the CIE of the intent to do so and ensuring that final edited publication in the *Proceedings of the CIE* is properly credited and that the relevant copyright terms are repeated verbatim. For any other use, the CIE must be contacted for prior approval.

The Publishers retain the right to withdraw any submitted work from the publication process in case relevant confirmations, payments or documents as necessary to proceed with the publication are not received and/or if it is found at any later stage that any of the authors failed to comply with the terms and conditions of and in relation to this publication agreement (as confirmed by the authors during the CIE 2025 final version submission process).

The following alteration and/or additions apply to this publishing agreement (becoming valid if authors confirm the corresponding checkboxes during the submission process):

- (1) Authors for whom Crown Copyright applies have the option to confirm the following statement during the final version submission process, altering the terms of the publishing agreement accordingly, where implied:

*“I/we certify that the contribution was written in the course of employment by or as part of contract undertaken for the UK, Canadian, Australian, or other Commonwealth Realm Government. Therefore, the Crown retains and asserts copyright, and is granting a non-exclusive license to publish the article and which hereby recognizes the Publishers as the exclusive licensees for the publication of the final, definitive, and citable Version of Record.”*

- (2) Authors for whom so called (US or other) Government exemptions apply, have the option to confirm the following statement during the final version submission process, altering the terms of the publication agreement accordingly, where implied:

*“I/we certify that the contribution was written in the course of employment by the (United States or other) Government, and copyright protection is therefore not available.”*

The following alteration and/or additions apply to this publishing agreement, becoming valid if authors chose the open-access publishing option for Full-length Papers during the submission process:

For the payment of an author fee of EUR 400 (fees to be received by June 16, 2024), the Full-length Paper will, in addition to being included in the complete CIE 2025 Proceedings volume (for sale on the CIE webshop) be published open-access (free-of-charge) for the general public under the Creative Commons License [CC-BY-NC](#) in the CIE web shop and on the CIE website.

The terms of the publishing agreement as stated above are altered accordingly.
